



- Consider CFLs for hard to reach lights
- CFLs are recommended for places where lights are on for 3 or more hours per day
- Do not use on dimmer switches
- Choose products rated for the place where you want to install them – table lamp, enclosed fixture, outdoor use, recessed cans, bathroom light bar
